

Bretz Injury Law is excited to present the 4th Annual Reno County Veterans' Memorial Poker Run happening in Hutchinson, KS on Saturday, September 9th. Registration will begin at 9:30 a.m. with engines starting at 10:30 a.m.

The Poker Run will begin at Salty Cycles, 129 E Sherman, Hutchinson, KS. Poker run stops include Sterling City Park, Shane Love Insurance Agency in Arlington, Shep Chevrolet in Haven, the Reno County Veterans' Memorial in South Hutchinson, and Bretz Injury Law in Hutchinson. The entry fee is \$25/hand and \$10 for each additional hand with donations also being accepted. All vehicles are welcome to participate.

Prizes will be awarded to the winning hand, the second best hand, and the worst hand. The winning hand will receive 25%, the second best hand will receive 15%, and the worst hand will receive 10%. The remaining 50% will be donated to the Reno County Veterans' Memorial. Door prizes and a meal will be provided following the run. Raffles will be held at the last stop, Bretz Injury Law, with proceeds benefiting the Veterans' Memorial.

"I remember my mother in fragments.

I know that her name was Terri and that she was 44 when I was born. I know that we lived in a one-bedroom apartment in San Diego, just the two of us and our cat. I know we didn't have a lot of money, so it wasn't an ideal situation, but it was our situation. We made the best of it and she did everything she could for me.

I know she loved listening to music and making me laugh. She played a lot of records - she loved artists like the Commodores and Toto and Earth, Wind and Fire. I know she worked very hard to make ends meet and keep a roof over our heads.

But that's where my memories mostly end. My mother was killed by a drunk driver on New Year's Day 2000 when I was just 5 years old."

## **Football Cake Pops**

#### **Ingredients:**

1 chocolate cake mix 1 cup cream cheese frosting 1 cup dark chocolate chips 1 cup peanut butter chips 1 tablespoon shortening 48 4-inch lollipop sticks 1/4 cup white decorating icing

#### **Directions:**

Bake cake according to package directions; cool completely. In a large bowl, break cake into fine crumbles. Add frosting and stir until fully incorporated, adding more frosting if needed, until mixture maintains its shape when squeezed together with palm of hand.



Shape 1 tablespoon into a ball, then mold into the shape of a football. Repeat with remaining mixture. Place on parchment-lined baking sheets; refrigerate until firm, about 30 minutes. Meanwhile, place chocolate chips, peanut butter chips and shortening in a microwave-safe bowl. Microwave 30 seconds and stir; repeat, stirring every 30 seconds until melted and smooth, adding more shortening if needed. Do not overheat. Dip a lollipop stick into chocolate mixture; insert halfway through a football shape, taking care not to break through the other side. Return to baking sheet until set; repeat to form remaining cake pops. Coat each cake pop with the chocolate mixture, allowing excess to drip off; reheat and stir chocolate mixture as needed. Return cake pops to baking sheets, ensuring they do not touch one another. Allow chocolate coating to set until firm to the touch. To decorate, use icing to draw laces onto cake pops.
